Sure WiFi SERVICE PRODUCT DESCRIPTION

The Sure (Guernsey) Limited WiFi service is an unencrypted, public service allowing users with wireless compatible devices such as laptop computers and Personal Digital Assistants (PDAs) to access the Internet. Once connected, comprehensive use of all Internet services is provided without charge. No Sure customer support is available for this service.

Service Specific Terms and Conditions

These Sure Service Specific Terms and Conditions should be read in conjunction with the Sure General Terms and Conditions. Where there is conflict these Service Specific Terms and Conditions supersede the General Terms and Conditions.

1. DEFINITIONS AND INTERPRETATION
